Claims Privacy Notice

1. Cork City Council has created this privacy notice to demonstrate our firm commitment to privacy and to assure you that all your dealings with the Rates Office will adhere to the general principles of data protection and your data is :
 - Processed lawfully, fairly and in a transparent manner
 - Collected for specified, explicit and legitimate purposes
 - Adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed ('data minimisation')
 - Accurate and, where necessary, kept up to date
 - Kept in a form which permits identification of data subjects for no longer than is necessary for the purposes for which the personal
 - Processed only in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing.
2. **Purpose** – Depending on the service/charge being provided or paid for, the information collected may include 'personal data' as defined by the Data Protection Acts and by the General Data Protection Regulation 2016 (GDPR) and may relate to current, past and future service users.

The Claims Section may hold information that has been provided by you but also from external sources, such as professional representatives engaged by you. The personal information held may include but is not limited to:

- Your name, address & telephone number
- PPSN
- Gender
- Email Address
- Qualifications
- Disability declaration
- Date of Birth
- Medical Reports
- References
- Bank Details
- Driver's Licence/Passport
- Personal Financial Details
- Work Promotions
- Social Welfare Records

3. **Legal Basis** - The legal basis and legitimate interest for processing personal data are included in;
 - Employment Legislation
 - Health & Safety Legislation
 - Injuries Board Legislation
 - Superior, Circuit and District Court Rules
 - Solicitors Legislation

4. **Information Sharing** - The Council may share your information internally (within the Council) in accordance with statutory obligations. In addition, the Council may share your information with third parties in accordance with statutory and regulatory obligations. The Claims section (Finance) of the Council may request, obtain, and/or share information, in carrying out its various functions, from/with the following bodies;
 - Members of the Legal Profession working on our behalf,
 - Insurers to the Local Authority,
 - Solicitors/Consultants acting on behalf of customers,
 - Other Bodies with which we have a contractual relationship

5. **Retention** -Your information will be retained in accordance with the Local Authority National Records and Retention Policy 2002 as updated.

6. **Right to amend inaccurate information** - Cork City Council must take reasonable steps to ensure that personal data it holds is correct, complete and up to date. If the data held by us is found to be inaccurate, misleading or incomplete you have the right to request rectification of the data.
